- Rings made in brass CW508L according with norm UNI EN 1252:1999
- Screw nut hot forged in brass CW617N UNI EN 12165:2016 steel sand blasting
- Pipe connection in compliance with UNI EN 1254-2 and UNI EN 1254-4 standards
- Threads are in compliance with UNI EN 10226 (threads where pressure tight joints are made on the threads) and/or UNI EN ISO 228 (threads where pressure tight joints are not made on the threads) standards
