- BODY OF FITTING is made with hot forged brass CW617N - UNI EN 12165:2016 steel sand blasting;
- CONTAINMENT CUP is made with hot forged brass CW617N - UNI EN 12165:2016 steel sand blasting;
- O-RINGS are made with EPDM Peroxid approved for drinking water by: WRAS, KTW, DVGW, NSF, ACS and compliant with FDA;
- ANTICONTACT RING that avoid contact between aluminium layer and brass is made with P.T.F.E.;
- DISK SPRING is made with stainless steel AISI 304 - UNI EN 10204;
- The SPACER RING is made with normalized brass CW614N - UNI EN 12164;
- Threads are in compliance with UNI EN 10226 (threads where pressure tight joints are made on the threads) and/or UNI EN ISO 228 (threads where pressure tight joints are not made on the threads) standards;
