DECLARES under its own responsibility that the products:

COMPRESSION FITTINGS FOR CROSS-LINKED POLYETHYLENE PIPES "WINNY-PEX"

produced according to EN ISO 15875

Are manufactured in the followings phases:

- MACHINED with the best forefront technologies in the factory located in Brandico (Italy)
- CONTROLLED in accordance with the strict operating procedures of its System of Quality Management in compliance with norm UNI EN ISO 9001:2008 (Certificate n. 0614426)
- Packaged and stocked properly in order to guarantee the integrity in time during storage and transport.

Declares furthermore that:

- Body of fitting made in hot forged brass CW617N - UNI EN 12165:1999 steel sand blasting or in normalized brass rod CW614N - UNI EN 12164:2001
- Fitting's body is treated with a thermo-chemical process in order to reduce the percentage of released lead to drinking water below the limit ($<0.015\text{mg/liter}$ at tap) set by the ANS/NSF61 - AS/NZS 4020 standards
- Ring is made with brass CW614N according with norm UNI EN 12164:2001
- Screw nut is made with hot forged CW617N - UNI EN 12165:1999 steel sand blasting
- Pipe connection is compliant with UNI EN 1254-3 standard
- Threads for external connections are in compliance with UNI EN 10226 (threads where pressure tight joints are made on the threads); threads for the coupling with the nuts are compliant with UNI EN ISO 228 (threads where pressure tight joints are not made on the threads)
- The components are marked according to EN ISO 15875

NTM SpA declares that all the above mentioned products can be used in fixed equipment of picking, treatment, adduction and distribution of water intended for human consumption in accordance to Italian Law D.M. 174 dated 06/04/2004.

NTM SpA declares furthermore that all its products are covered by policy of principal Insurance Company against risks of wrong manufacture and/or design.
